- o The summer meetings will be outside

• REGINALD SCOTT, CFO OF LANDBANK AUTHORITY:

- Started in April 2016 in the Sales Department
- The Detroit Landbank is the largest landbank. Had 100,000 properties
- Over 20-30 years, people have been moving out of the City and vacancies increased
- As a result, Detroit has a number of vacant properties either salvageable or not
- Those that were not salvageable were scheduled to be demolished
- Nearly 17,000 have been demolished
- 15,000 have been sold or restructured
- The structures that are salvageable goes to the Landbank.
- The Landbank does not foreclose on any of them
- o The program is to alleviate blight
- Want to make them available through an auction
- Once you win the property eligibility is checked
- Check for blight tickets or blight that needs to be removed
- Check for residency foreclosures
- o There are very few properties that are eligible to be lived in as soon as you win
- Not trying to sell at the market value because of the work that will need to be done
- Vacant lots and side lots are also owned by the Landbank that are available for purchase
- The goal is to sell these lots to neighbors
- The neighbors do not have to pre qualify
- The properties are focused to sell to Detroiters

- Another challenge is occupied structure owned by the Landbank but can't be sold because they're occupied
- The homes are not habitable and should not be occupied
- Six years ago a lot of individuals were renting but were duped because the landlord lost the property
- The program allows those individuals who are connected to the property to be given the opportunity to buy the property
- It captured 1100 people to buy homes. It's an effective program but does not capture everyone
- The Landbank partners with U Snap Bac and Fifth Third Bank
- Programs are designed to get those properties into the hands of Detroiters and those residents that are connected to the homes
- When the property is purchased from Landbank, a deed is signed to that person
- In the event, the person does not comply with the agreement, the property goes back to the Landbank
- o The policy was established to sell neighborhood lots to neighbors that live nearby
- Website is buildingdetroit.org you can see every side lot that is available
- Nuisance Abatement Program designed to get the owner to comply to get the home up to code and habitable
- When acquiring about a property to the Landbank, have a specific address
- MorningSide has 2 oversize lots, 315 neighborhood lots, 90 side lots that are listed
- If a lot is not listed, it's because that lot is not eligible yet, for instance after demolition
- You can apply for that lot through the City application
- o That property will come to the board to review the lot and see why it's not listed
- The Landbank gets the property through the Wayne County Treasurer office when properties are foreclosed on

• COUNCILMEMBER LATISHA JOHNSON:

- o Focus is on lower income renters \$40,000 a year maximum
- o Must have been a renter for at least 12 months in Detroit
- 100 2-unit townhouses in District 4 is being developed
- Families are being identified through U Snap Bac, ECN, and Meca
- o ECN breakfast, coffee hour
